

## **Purpose**

These Bylaws are intended to document/clarify rules that are not established on the website. All other rules can be found under the rules section of the website.

## **Draft**

Draft consists of 16 rounds and will be a 3rd round reverse draft. Picks will go 1-12, 12- 1, 12-1, 1-12, 12-1, 1-12 and so on till all 16 rounds are complete Draft order will be determined before the draft by random drawing.

## **Divisions**

The 12 teams will be split into 2-6 team divisions. Picks 1,3,5,7, 9, & 11 will make up division A. Picks 2,4,6,8, 10, & 12 will make up division B

## **Schedule**

Teams play each team in their division twice and each team in the opposite division once. Regular season is weeks 1 through 13. Playoffs occur in weeks 14, 15, and 16.

## **Playoffs**

Each division winner will make the playoffs and receive a 1st round bye. The next 4 highest ranking teams will make the playoffs regardless of division. The division winner with best record will be awarded the #1 seed and second division winner will be the #2 seed. Remaining seeds determined by record. See separate document for season tiebreakers to determine playoff seeding.

## **Homefield Advantage:**

The higher seed in the playoffs will receive a homefield advantage that is determined by the difference in seed values. For example if the 4 seed is playing the 5 seed the 4 seed will get a 1 point advantage. If the 1 seed is playing the 5 seed the 1 seed will get a 4 point advantage. No homefield advantage will apply in the superbowl.

## **Game Tiebreakers:**

1. Highest scoring individual starter
2. Highest scoring individual starters 2-10
3. Highest scoring bench player
4. Highest individual scoring bench players 2-6
5. If still tied, the game is declared a tie

## **League Finances**

Each Team will pay a \$100 entry fee (\$1,200 total prize pool awarded for playoffs)

\$425 + the remainder of the redraft pool awarded to the superbowl winner (\$425)

\$175 awarded to the superbowl loser (\$175)

\$150 awarded to the division winners (\$300)

\$25 awarded to the 4 wildcard playoff teams (\$100)

\$40 awarded to teams for winning a 1st round playoff game (\$80)

\$60 awarded to teams winning a 2nd round playoff game (\$120)

The money collected from trades & redrafts will be paid as follows:

\$110 +/- goes towards the payment of rtsports, draft board kit, and trophy engraving

50% paid to the highest scorer for weeks 11-13 combined  
25% paid to the single highest team scorer throughout the entire regular season (wk 1-13)  
\$25 or 25% (whichever is less) paid to the single lowest team scorer throughout the entire regular season.  
The remaining money will go to the superbowl winner.

In order to qualify for the lowest scoring team, you must start a full legal roster with no players on bye, on the NFL's injured reserve list, or players listed as OUT by Wednesday of that week's games. An injured player not listed as out and doesn't play will be allowed to qualify for this pot.

## **Sportsmanship Clause**

Any team that fails to start a valid lineup for two weeks will be fined \$50 (applied to redraft pool). Failure to not set a valid lineup after fine may lead to disbarment from the league in upcoming seasons. A valid lineup is a full legal starting lineup with no players on bye, on the NFL's injured reserve list, or players listed as OUT by Wednesday of that week's games. An injured player not listed as out and doesn't play is not a violation of this clause.
